Letter from the President *You Saw Us Through*



We're excited to be celebrating 2021 with you by our side – we know this year will bring great futures for the homeless animals at Wayside Waifs.

However, we can't ignore the challenging year we encountered last year. Despite the difficult times, you saw us through and saved the lives of so many animals in our care. We are extremely appreciative of you!

Thousands of homeless animals came to Wayside and received comprehensive medical and behavior care that they deserve. Animals were saved from hoarding situations, rescued from hurricanes, and found homeless on streets – then brought to Wayside where they received warmth, nutritious

food, and love. Our veterinary staff worked tirelessly to ensure the animals' care didn't waiver. They performed everything from medical exams to dental cleanings to life-saving surgeries. Our behavior team devoted their care to the animals who need it most – those who were stressed, high-energy, or simply struggling in the shelter. And after all of this... after everyone came together to give the Waifs a newfound life of health and happiness... the animals found their forever homes. Through virtual and in-person adoptions animals met their new best friends.

As you may know, The Building Dreams and Saving Lives Capital Campaign was completed and the ribbon cuttings for the new spaces took place in October of last year. First, the Education & Training Center was built to allow Wayside to reach more of the community in various ways. Second, the Canine Behavior Center was added to provide a calm and controlled space for our behavior team to work with our shy, fearful and high-arousal dogs. Great things are ahead for Wayside Waifs in 2021 and we can't wait to share them with you! We look forward to the continuation of life-saving miracles that save homeless animals every day. And we can't wait to see you in person (when it's safe).

Wayside Waifs has been in Kansas City since 1944 – on the same piece of property! While we’ve been preparing pets and people for the bond of their lives the entire time, we’ve encountered several changes.

In August of 2019, we embarked on The Building Dreams and Transforming Lives Capital Campaign. This was an effort to add much needed growth to Wayside allowing us to save more animals and reach more in the community.

Partners on the project included A.L. Huber Construction and SFS Architects. Tom and Jill Turner and Dave and Sandy Johnson led the fundraising campaign efforts as Co-Chairs.

Fourteen months later, in October of 2020, construction on this project was complete. The \$8.7 million project includes the Education & Training Center (ETC) and the Canine Behavior Center (CBC).

The Education and Training Center (ETC)

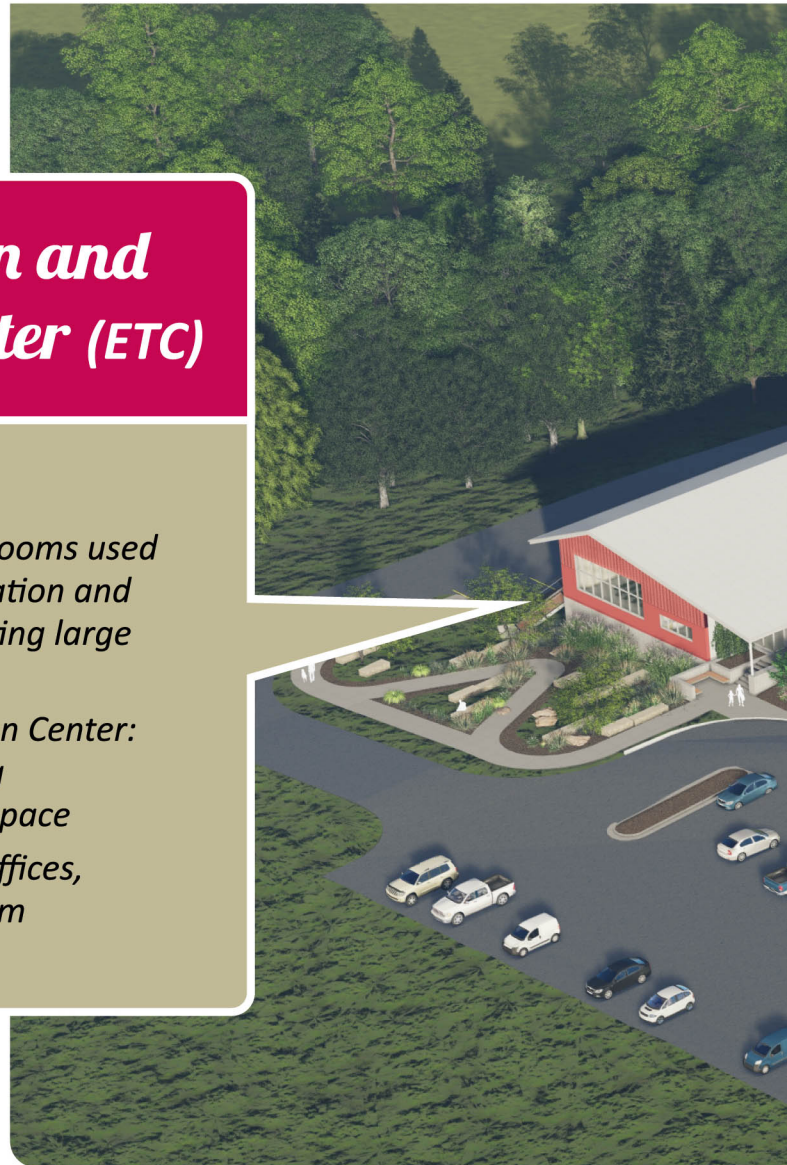
- *11,000 square feet*

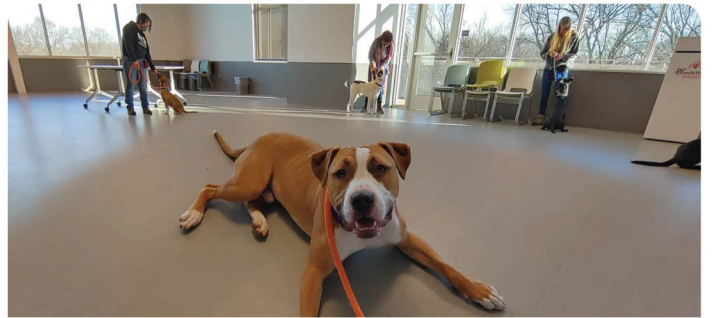

It includes nine pet-friendly offices with Dutch doors, each generously sponsored by different donors. One office is named in memory of Toby, the Beeson’s beloved Yorkie, their last pet together. The open air collaboration area is a focal point and gathering spot of the Beeson Center – it is sponsored by longtime supporters Rusty and Martha Smith. The center is named after Robert and Carole Beeson, longtime animal lovers that also believed in the importance of education.

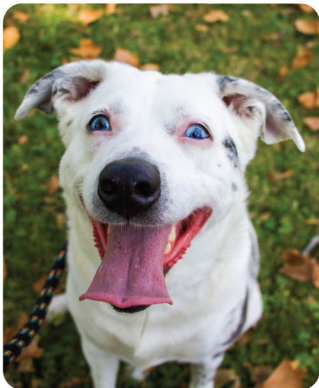
